GDP growth rate in 2024 according to preliminary estimates

According to the preliminary estimate, the increase of real gross domestic product (GDP) in 2024 was 2.9% compared with 2023, against the increase of 0.1% in 2023 (constant average prices of the previous year).

According to the preliminary estimate the increase of real gross domestic product in 2024 was 2.9% after the increase of 0.1% in 2023. Based on currently available data, the following volume growth rates of gross value added were estimated:


- gross value added in national economy in 2024 increased by 2.1% compared with the previous year against the increase by 1.2% in 2023,
- gross value added in industry in 2024 increased by 1.0% compared with the previous year against the decrease by 0.8% in 2023,
- gross value added in construction in 2024 decreased by 6.7% compared with the previous year against the increase by 0.4% in 2023,
- gross value added in trade and repair in 2024 increased by 2.3% compared with the previous year against the increase by 0.5% in 2023.

Domestic uses in 2024 was 4.1% higher than in 2023 when the decrease of 3.1% was noted.

Total consumption expenditure in 2024 increased by 4.0% compared with the previous year, in which consumption expenditure in the households sector increased by 3.1% (in 2023 the increase of 0.7% and decrease of 0.3% respectively was recorded).

Gross fixed capital formation in 2024 compared with the previous year was higher by 1.3% (in 2023 the increase of 12.6% was observed). The investment rate in the national economy (relation of gross fixed capital formation to gross domestic product at current prices) was 17.4% in 2024, while in 2023 was 17.7%.
