Change in current consumer confidence indicator

In April 2025, there was a deterioration in both current and future consumer sentiment moods compared to the previous month. The current consumer confidence indicator, synthetically describing the current trends in individual consumption, was minus 16.5^a which was by 1.3 p.p. lower in relation to last month.

Current consumer confidence indicator in April 2025

Among the components of the indicator, the evaluations of the current possibility of making important purchases and current economic situation of the country deteriorated the most (decreases by 4.1 percentage points and 1.8 percentage points, respectively). A lower values were also recorded for the evaluations of the future financial situation of the household and future economic situation of the country (decreases by 1.6 percentage points and 0.2 percentage points, respectively). Higher value than a month before was recorded only for the evaluation of the current financial situation of the household (increase by 1.1 percentage points).

Referring to April 2024, the current value of current consumer confidence indicator is lower by 5.0 percentage points.

Leading consumer confidence indicator in April 2025

The leading consumer confidence indicator, synthetically describing trends in individual consumption that are expected in the coming months, decreased by 2.0 percentage points in relation to the previous month, and was at the level of minus 11.8^a.

The decrease of the value of the indicator was affected by all of its components. The largest decrease was recorded in the evaluation of the future level of unemployment (by 3.6 percentage points). For the other components of the indicator, the decreases were as follows: by 2.5 percentage points in evaluation of the possibility of future money saving, by 1.6 percentage points in the evaluation of the future financial situation of a household and by 0.2 percentage points in the evaluation of the future economic situation of the country.

In April this year leading consumer confidence indicator reached a value lower by 5.0 percentage points than in the corresponding month of 2024.

Answers to additional questions in connection with the current situation on the territory of Ukraine are presented in the annex.

^a Both consumer confidence indicators receive values between -100 and +100. A positive value means dominance of consumers with optimistic attitude over consumers with pessimistic attitude, while negative value means dominance of consumers with pessimistic attitude over consumers with optimistic attitude. In the period of 07-16.04.2025, 1324 interviews were conducted.

Chart 1. Current consumer confidence indicator and its component values by month in 2022–2025




Chart 2. Current consumer confidence indicator and its component values by years



Chart 3. Leading consumer confidence indicator and its component values by month in 2022–2025





Chart 4. Leading consumer confidence indicator and its component values by years

respondents declared the impact of the current situation on the territory of Ukraine on responses regarding the consumer tendency (in March it was 60.9%)


In April 2025, for 27.6% of respondents, the current situation on the territory of Ukraine poses a big threat for the sovereignty and independence of Poland (decrease of 8.4 percentage points compared to the previous month).

Impact of the current situation on the territory of Ukraine on responses to the consumer tendency

From among respondents declaring the impact of the current situation on the territory of Ukraine on responses regarding the consumer tendency 43.6% described it as moderate and 14.9% as significant. For 41.5% of respondents, the current situation had no impact on the answers.

Chart 1. Impact of current situation on the territory of Ukraine on responses - response structure (%)




Fear of losing a job or stopping running your own business due to the current situation on the territory of Ukraine

Among the employed^b 1.1% of respondents have a definite fear of losing their job or stopping their own business. For the "possible" and "rather not" options, the response rate was 8.7% and 31.2%, respectively. The percentage of working people who do not have any concerns is 53.9%. A small number of working respondents (5.1%) had no opinion.

Chart 2. Fear of losing your job or stopping your own business due to the current situation on the territory of Ukraine - structure of responses for employees (%)




What threat is the current situation on the territory of Ukraine for the economy in Poland

According to 24.9% of respondents, the current situation on the territory of Ukraine is a big threat for the economy in Poland. The average threat to the economy is felt by 45.3% of respondents. Only 24.9% declare a small threat, while 4.9% of respondents declare no threat.

Chart 3. What is the threat of the current situation on the territory of Ukraine for the economy in Poland - response structure (%)




What threat is the current situation on the territory of Ukraine for personal financial situation

For 6.7% of respondents, the current situation on the territory of Ukraine is a big threat for their personal financial situation. The average threat is felt by 30.6% of those who answered the questions about the consumer tendency. A small threat is declared by 36.0%, while no threat was stated by 26.7% of respondents.

What threat is the current situation on the territory of Ukraine for the sovereignty and independence of Poland

For 27.6% of respondents, the current situation on the territory of Ukraine is a big threat for the sovereignty and independence of Poland. The average threat is felt by 39.8% of those who answered the questions about the consumer tendency. 26.3% declare a small threat, while only 6.3% of respondents declare no threat.

Chart 5. What is the threat of the current situation on the territory of Ukraine for the sovereignty and independence of Poland - response structure (%)


